Maintenance schedule - December activities

Proposed floor cleaning – the clerk has received a quote to have the floor re sanded and sealed - £2330. After discussion decided to try mopping a couple of times, before getting anymore quotes, proposed Mrs Blackburn, seconded Mr Bevans

Cleaning bus shelter and phone box – Mrs Blackburn agreed to do this along with the crossroad bench

Mr Bust has spoken to Mrs Beckett again, she has decided that she is not happy with the wall being lowered, after the problem with the party and the possibility of devaluing her house Agreed to maintain the height, just look at repairing the damaged section. Agreed to look at putting a wooden gate there proposed Mr Paris, seconded Mr Bust

<u>Dec 24 9</u> <u>Christmas mulled wine and mince pies – update on the event – volunteers to take down decorations – disposal of Christmas tree</u>

Thanks were given to the PC by the member of the public present, thanks from the PC were given to Mrs Denyer and Mr and Mrs Blackburn, for their efforts

The clerk agreed to take down the tree, Mrs Denyer the decorations and return the reindeer to Mrs Blackburn

Agreed to get Southwell YFC to remove the Christmas tree – clerk to contact - £5 removal fee for charity - agreed

Dec 24 10 hand over of website and bookings from Mr Bevans

As Mr Bevans is leaving next year, it was decided to start handing over things. A new editor has been found for the Village News

Mr Wright offered to take on the bookings for the Village Hall

Mrs Blackburn will take on the website

The clerk had received confirmation that Mr Bevans could continue as a Cllr after moving as long as he attended meetings in person, so that the 6 month rule would not come in, until the end of his term

The money - Co-op voucher at the moment – is distributed to any household in Halam who has a resident over 60
